**INVITATION FOR BIDS (IFB)**

The Office of the Mission Director, National Rural Health Mission, Assam, Guwahati-5 invites bid for the work under NRHM as detailed below **ON TURN KEY BASIS** and **ON TWO BIDS SYSTEM**.

1. **Eligibility Criteria:**

- (a) Registered APWD (Bldg) Class I-(A) / CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking
  - (b) Contractor must have satisfactory completed
    - (i) Four similar works, each of value not less than 25% of the estimated cost put on tender or
    - (ii) Three similar works, each of value not less than 40% of the estimated cost put on tender or
    - (iii) Two similar works, each of value not less than 50% of the estimated cost put on tender or
    - (iv) One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited.
  - (c) Contractor must have achieved Annual Turnover of at least Rs.8.50Crores in any **TWO YEARS** during last 5 years.
  - (d) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital Building projects on earlier occasion.
  - (e) The contractor who was earlier allotted any NRHM works by PWD(B), Assam or by NRHM and could not complete the work in all respect **in time** will not be **ELIGIBLE** to participate in the bidding process.
  - (f) The contractor and to whom extension of time was granted from NRHM imposing penalty will also be not **ELIGIBLE** to participate in the bidding process.
  - (g) The intended bidders are asked to verify the site for the work prior to quoting their rates.
2. Cost of tender document should be drawn in favour of **State Health Society, Assam**, payable at **Guwahati** in the form of Pay Order/Demand Draft.
  3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the **State Health Society, Assam**, payable at **Guwahati**.
  4. Pre-bid meeting date and time: **30/12/2013 at 16-00 hrs.**
  5. Date for issuing of Bid Document: **26/12/2013 to 27/12/2013**
  6. Last date and time of submission of Bid: **08/01/2014 at 14:00 hrs at the office of the Mission Director, NRHM, Assam.**
