- a) Registered APWD (Bldg.) (Electrical) Class I-A/B/C, Class II, Class III/APDCL/Contractor having valid Electrical License.
 - b) The Contractor should have at least one similar nature of completed work value not less than 80% of the estimated cost during last 2 years.
 - c) The Contractor having PAN Card/GST Registration/Labour License/Registration under EPF and MP Act, 1952 etc. are ELIGIBLE to participate in the bid process.
 - d) The intended bidders are asked to verify the site of the work prior to quoting their rates.
 - e) The intending bidders or their authorized representatives are to be present at the time of opening of bids. Otherwise, the bids will be opened in their absence and no claim will be entertained in future.
- 2) Cost of tender documents should be drawn in favour of **State Health Society, Assam** Payable at Guwahati in the form of **Pay Order/Demand Draft**.
