(ii) Two similar works, each of value not less than 50% of the estimated cost put on tender or (iii) One similar nature of completed work valued at not less than 80% of the proposed project cost during last 7 (Seven) years ending on the last day of the month previous to the one in which the tenders are invited.

(c). The Contractor having PAN Card/GST Registration/Labour License/registration under EPF and MP

ACT 1952 etc., is <u>ELIGIBLE</u> to participate in the bid process.

(d). In case the evaluated bid amounts are equal, preference for allotment of the project will be given to the bidder who has completed Building works under NHM on earlier occasion.
