The Office of the Mission Director, National Health Mission, Assam invites bid for the works under NHM in single bid system (in F2 form) affixing court fee stamp of Rs.8.25 (Rupees Eight and Twenty Five Paisa) only for the works as detailed below:-

1. Eligibility Criteria:-

(a). Registered APWD (Bldg) /Class I-A/B/C/Class II/Class-III/CPWD Contractors/Reputed Const. Company/Agency registered under Govt./ Public sector undertaking.

(b) Contractors must have satisfactorily complete at least

(i) Three similar works, each of value not less than 40% of the estimated cost put on tender or

- (ii) Two similar works, each of value not less than 50% of the estimated cost put on tender or
- (iii) One similar nature of completed work valued at not less than 80% of the proposed project cost during

last7 (Seven) years ending on the last day of the month previous to the one in which the tenders are invited. (c). The Contractor having PAN Card/GST Registration/ Labour License / registration under EPF and MP ACT 1952etc,

are **ELIGIBLE** to participate in the bid process.

(d). In case the evaluated bid amounts are equal, preference for allotment of the project will be given to the bidder who has completed Building works under NHM on earlier occasion.

(e). The intended bidders are asked to verify the site for the work prior to quoting their rates.

(f). The intending bidders or their authorized representatives are to be present at the time of opening of Bids.

Otherwise the bids will be opened in their absence and no claim will be entertained in future.

2. Cost of tender document should be drawn in favour of State Health Society, Assam, payable at Guwahati in the form of Pay Order/Demand Draft.

3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of TDR/FDR/CDR and drawn in favour of the State Health Society, Assam, payable at Guwahati.

4. Date of receipt of application along with cost of tender document and copies of documents as per eligibility criteria mentioned at SI.1 (a), (b) & (c) to issue Bid Document :- 30/01/2025 to 3..../02/2025 during working hours.

5. Last date for issuing of Bid Document: 4.3. /02/2025 up to 12-00 hrs.
