The Office of the Mission Director, National Health Mission, Christian Basti, Guwahati-5 invites bid for the following works on **TWO BIDS SYSTEM** as detailed below-

#### 1. Eligibility Criteria:

- (a)Registered contractor of APWD (Bldg.) Class I(A/B/C)/Class II/ CPWD/ Reputed Construction Company/ Agency registered under Govt./Public Sector undertaking
- (b)Contractor must have satisfactory completed
  - (i) Three similar works, each of value not less than 40% of the estimated cost put on tender or
  - (ii) Two similar works, each of value not less than 50% of the estimated cost put on tender or
  - (iii) One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 7 years ending on the last day of the month previous to the one in which the tenders are invited.
- (c) Contractor must have achieved Annual Turnover of at least 30% of estimated cost in any Three Years during last 5 years.
- (d) The Contractor having PAN Card/GST Registration/Labor License registration under EPF & MP Act, 1952 etc. are eligible to participate in the bid process
- (e) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital Building projects on earlier occasion.
- (f) The intended bidders are instructed to physically visit and verify the site for the work prior to quoting their rates and submit an undertaking as per format enclosed with the SBD to be countersigned by the concerned Site Engineer.
- 2. **Tender processing fees** should be submitted **ONLINE** by Internet Banking through **State Bank of India (SBI)** or any other bank listed at State Bank Multi Option Payment System (SBMOPS) on http://assamtenders.gov.in
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be submitted **ONLINE** by Internet Banking through **State Bank of India (SBI)** or any other bank listed at State Bank Multi Option Payment System (SBMOPS) on <a href="http://assamtenders.gov.in">http://assamtenders.gov.in</a>
- 4. The Contractor/ bidder must be registered with the Electronic Tendering System (ETS) of the Govt. of Assam (website http/assamtenders.gov.in). Contractors/ Bidders can download documents free of cost. Contractors/ Bidders have to necessarily down load the bidding document from the ETS using their own ID (Digital Signature Certificate). Bid documents not procured (downloaded) through the ETS/not using the contractor's own user ID will be considered invalid and summarily rejected. Contractors submitting bids online have to submit copy of the documents of technical bid required to be submitted manually before the expiry of the sequence 'Online Bid Submission' date and time as mentioned in the tender schedule. Bid will be rejected/ cancelled if Financial Bid submitted off-line/hard copy.
- Bidders must submit original copies of the following documents A) Bank solvency certificate/ Credit Facilities.
  - B) All Affidavits including Affidavits for tie up of electrical and anti Termite License.
