The office of the Mission Director, National Health Mission, Christain Basti, Guwahati-5 invites bid in single bid system (In F2 form) affixing court fee stamp of Rs 8.25 (Rupees Eight and Twenty Five Paise) only for the work as mentioned below:

1) Eligibility Criteria:

- Registered APWD (Bldg.) (Electrical) Class I-A/B/C, Class II, Class III/APDCL/Contractor having valid Electrical License.
 - The Contractor should have at least one similar nature of completed work value not less than 80% of the estimated cost during last 2 years.
 - The Contractor having PAN Card/GST Registration/Labour License/Registration under EPF and MP Act, 1952 etc. are ELIGIBLE to participate in the bid process.
 - The intended bidders are instructed to physically visit and verify the site for the work prior to quoting their rates and submit an undertaking as per format enclosed with the SBD to be countersigned by the concerned Site Engineer.
 - The intending bidders or their authorized representatives are to be present at the time of opening of bids. Otherwise, the bids will be opened in their absence and no claim will be entertained in future.
 - In case the evaluated bid amounts are equal, preference for allotment of the project will be given to the bidder who has completed such projects on earlier occasion.
- Cost of tender documents should be drawn in favour of **State Health Society, Assam** Payable at Guwahati in the form of **Pay Order/Demand Draft**.
 - Bid security with a validity of 225 (i.e. 180+45) days should be in the form

of **TDR/FDR/CDR** and drawn in favour of the **State Health Society, Assam** Payable at Guwahati.

4) Date of receipt of application along with cost of tender document and copies of documents as per eligibility criteria mentioned in Sl.1(a),(b),(c) to issue bid documents: **22/01/2026** to **12/02/2026** during working hours.
