1. Eligibility Criteria:

- (a) Registered APWD (Bldg) Class-I(C) & Class-II /CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking.
 - (b) Contractors having completed works at least one similar nature of completed work value not less than 80% of the proposed project cost.
 - (c) The contractor who was earlier allotted any NRHM works and could not complete the work in all respect in time will not be ELIGIBLE to participate in the bidding process.
 - (d) The contractor & to whom extension of time was granted from NRHM imposing penalty will also not be **ELIGIBLE** to participate in the bidding process.
- (e) The contractor to whom show cause notice for slow progress was issued will not be **ELIGIBLE** to participate in the bidding process.
- Cost of tender document should be drawn in favour of State Health Society, Assam, payable at Guwahati in the form of Pay Order/Demand Draft.
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the **State Health Society, Assam,** payable at **Guwahati**.
