## **INVITATION FOR BIDS (IFB)**

The Office of the Mission Director, National Rural Health Mission, Assam invites bid for the works under NRHM as detailed below **ON TURN KEY BASIS** and **ON TWO BIDS SYSTEM**.

- 1. Eligibility Criteria:
  - (a) Registered APWD (Bldg) Class I-(A) & I-(B) / CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking
  - (b) Contractor must have satisfactory completed
    - (i) Four similar works, each of value not less than 25% of the estimated cost put on tender or
    - (ii) Three similar works, each of value not less than 40% of the estimated cost put on tender or
    - (iii) Two similar works, each of value not less than 50% of the estimated cost put on tender or

(iv) One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited.

- (c) Contractor must have achieved Annual Turnover of at least Rs. 1.49 Crores in any **<u>TWO</u>** <u>**YEARS**</u> during last 5 years.
- (d) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital related Building works on earlier occasion.
- (e) The contractor who was earlier allotted any NRHM works and could not complete the work in all respect **in time** will not be **ELIGIBLE** to participate in the bidding process.
- (f) The contractor and to whom extension of time was granted from NRHM imposing penalty will also be not **ELIGIBLE** to participate in the bidding process.
- (g) The intended bidders are asked to verify the site for the work prior to quoting their rates.
- 2. Cost of tender document should be drawn in favour of **State Health Society, Assam**, payable at **Guwahati** in the form of Pay Order/Demand Draft.
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the **State Health Society, Assam,** payable at **Guwahati**.
- 4. Date for issuing of Bid Document: 21-05-2014 to 22-05-2014
- 5. Last date and time of submission of Bid: 27-05-2014 at 14-00 hrs
  - a. The bids will be opened at 15.30 hrs of the same days as mentioned above.
  - b. In case, if any Bandh/Holiday falls in any sequence, the sequence will be held in the next working day.
