DETAILS OF EOI

FOR SUPPLY OF MANNEQUINS/MODELS FOR NURSING SCHOOLS

1) BACKGROUND:

The National Health Mission has been launched to carry out necessary architectural correction in the basic health care delivery system. The Mission adopts a synergistic approach by relating health to determinants of good health viz. segments of nutrition, sanitation, hygiene and safe drinking water. It also aims at mainstreaming the Indian systems of medicine to facilitate health care. The Plan of Action includes increasing public expenditure on health, reducing regional imbalance in health infrastructure, pooling resources, integration of organizational structures, optimization of health manpower, decentralization and district management of health programmes, community participation and ownership of assets, induction of management and financial personnel into district health system, and operationalizing community health centers into functional hospitals meeting Indian Public Health Standards in each Block of the Country. The Goal of the Mission is to improve the availability of and access to quality health care by people, especially the poor, women and children.

2) INVITATION FOR “EXPRESSION OF INTEREST”

On the basis of the requirement of different teaching accessories like Mannequins / Models in different Nursing Colleges, Schools and Training Centers, to provide health related education to the apprentices, NHM Assam intends to select competent agencies for supply of Mannequins/Models.

NHM Assam invites “expressions of interest” from reputed agencies for supply of Mannequins / Models. Expressions of interest along with prescribed documents must be dispatched so as to reach the place of submission (indicated below) on or before 2:00 PM of **16/09/2014**.

A brief of the requirements have been described in the following section.

3) CREDENTIALS

Only agencies having the following credentials are requested to respond:

- a) The agency should have prior experience of supplying teaching aids to Medical Institutes or biomedical equipments to Health Institutions under the Central/State Government. The agency should furnish details of such supplies during the last three financial years

Attested/notarized copy of orders executed for Govt. Organizations must be furnished.

- b) The agency should have Average Annual Turnover of at least Rs 500 Lakhs during the three financial years 2010-11, 2011-12 & 2012-13 or 2011-12, 2012-13 & 2013-14. They must furnish Annual Turnover Statement in the specified format at Annexure A certified by the Auditor/ Chartered Accountant.

4) EVALUATION / SELECTION PROCEDURE:

Evaluation / selection shall be carried out in the following stages:-

- (i) A selection committee of NHM, Assam, shall go through the documents of the agencies and prepare the list of parties fulfilling eligibility requirements.
- (ii) The shortlisted parties will be called for further discussions on technical and commercial parameters, if deemed necessary.
- (iii) Based on inputs received against this EOI a tender will be issued amongst the short listed agencies. They will be required to submit their bids in two parts – technical bid & price bid. Price bids of the agencies found to be technically acceptable shall be opened in presence of bidders.

5) PARTICULARS/DOCUMENTS TO BE SUBMITTED WITH SEAL / SIGNATURE AND A COVERING LETTER IN THE PARTY'S LETTERHEAD:

(i) Details of the establishment:

- a. Name and address of the agency with e-mail address and contact numbers
- b. Attested/notarized copy of Certificate of Registration of the Firm.
- c. Attested/notarized copy of VAT Registration Certificate
- d. Attested/notarized copy of Permanent Account Number (PAN) card.
- e. Annual Turnover Statement in the format at Annexure-A
- f. Any other useful information.

(ii) Details of Technical Specifications:

The agency should provide detailed technical specifications of each of the items listed at Annexure-B and furnish attested copies of certificates for quality assurance such as ISO, BIS, CE etc.

(iii) Other documents:

The agency should provide attested/notarized copies of orders executed for Government organizations during the last 3 financial years for supply of teaching aids to medical institutes or biomedical equipments to health institutions.

Interested agencies are requested to send their expression of interest in a sealed envelope, along with supporting credentials, so as to reach NRHM Assam on/before 2:00 PM of 16/09/2014 at the following address.
