1. Eligibility Criteria:

- (a) Registered APWD (Bldg) Class I-(A) / CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking
- (b) Contractor must have satisfactory completed
 - (i) Four similar works, each of value not less than 25% of the estimated cost put on tender or
 - (ii) Three similar works, each of value not less than 40% of the estimated cost put on tender or
 - (iii) Two similar works, each of value not less than 50% of the estimated cost put on tender or
 - (iv) One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited.
- (c) Contractor must have achieved Annual Turnover of at least Rs.75.00Crores in any $\underline{\text{TWO}}$ $\underline{\text{YEARS}}$ during last 5 years.
- (d) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital Building projects on earlier occasion.
- (e) The contractor who was earlier allotted any NHM works by PWD(B), Assam or by NHM and could not complete the work in all respect in time will not be ELIGIBLE to participate in the bidding process.
- (f) The contractor and to whom extension of time was granted from NHM imposing penalty will also be not <u>ELIGIBLE</u> to participate in the bidding process.
- (g) The intended bidders are asked to verify the site for the work prior to quoting their rates.
- 2. Cost of tender document should be drawn in favour of State Health Society, Assam, payable at Guwahati in the form of Pay Order/Demand Draft.
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the State Health Society, Assam, payable at Guwahati.
