- IV. <u>Eligibility Criteria</u>:
 - (a) Registered APWD (Bldg) Class I-(A/B/C)/Class-II/CPWD Contractors.
 - (b) Contractors having completed works at least one similar nature of completed work value not less than 30% of the proposed project cost.
 - (c) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Building works under NHM on earlier occasion.
 - (d) The contractor who was earlier allotted any NHM works and could not complete the work in all respect in time/within the period up to which extension of time was granted without penalty will not be ELIGIBLE to participate in the bidding process.
 - (e) The contractor and to whom extension of time was granted from NHM imposing penalty will also be not ELIGIBLE_to participate in the bidding process.
 - (f) The intended bidders are asked to verify the site for the work prior to quoting their rates.
