- I. Issue date of Bid document extended up to 07/03/2015
- II. Submission of Bid: 10/03/2015 at 14:00 hrs.
- III. Opening of Bid: 10/03/2015 at 15:30 hrs.
- IV. Eligibility Criteria:
  - (a) Registered APWD (Bldg) Class I-(A/B/C)/Class-II/CPWD Contractors.
  - (b) Contractors having completed works at least one similar nature of completed work value not less than 30% of the proposed project cost.
  - (c) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Building works under NHM on earlier occasion.
  - (d) The contractor who was earlier allotted any NHM works and could not complete the work in all respect in time/within the period up to which extension of time was granted without penalty will not be ELIGIBLE to participate in the bidding process.
  - (e) The contractor and to whom extension of time was granted from NHM imposing penalty will also be not ELIGIBLE to participate in the bidding process.
  - (f) The intended bidders are asked to verify the site for the work prior to quoting their rates.
  - (g) The bids submitted earlier in this office on 09/01/2015, 27/01/2015, 07/02/2015 and 24/02/2015 will be considered in the above bid process.
  - (h) If the bidders desire to modify their financial bid, they can submit the modification in separate sealed envelope on the extended date & time of submission of bid. The envelope shall have clear marking " MODIFICATION TO FINANCIAL BID" as per releavent clauses of the Bidding document.
