SHORT NOTICE INVITING TENDER FOR SUPPLY & INSTALLATION OF BATTERY

Date: 11.06.2015

Sealed quotations affixing court fee stamp of Rs 8.25 only, are invited from the manufacturer or their authorized dealers/distributors for supply & installation of Exide make battery with following terms and conditions and as per format at Annexure I. The quotations should reach the office of the Mission Director, National Health Mission Assam, Saikia Commercial Complex, Christian Basti, Ghy-781005 by 2.00 P.M. on 19.06.2015. The sealed quotations shall be opened on the same day at 3.00 P. M. in the office of the Mission Director, NHM Assam.

 Name of work: Supply & installation of 7 Nos. of Exide Brand Battery (12V, 150AH) to 20 KVA Online UPS in SNCU Moriagaon Civil Hospital, Morigaon.

Terms & Conditions:-

- Earnest Money Deposit (EMD) of Rs 3,000/- only in the form of Demand Draft/Banker's Cheque with validity of at least 3 months favoring "State Health Society, Assam". Earnest Money Deposit in any other form will not be accepted. Earnest Money Deposit will also not earn any interest.
- The Bidder (whether a manufacturer or an authorized dealer/distributor of the manufacturer) shall have to submit Sales Tax Clearance certificate, as on 31st March of last financial year along with copy of Trade License.
- 3. The technical & commercial requirements, wherever applicable, are specified in the attached questionnaire titled "Agreed Terms & Conditions" (Annexure-I) which should be filled in, signed & stamped on each page and shall be enclosed with your bid. Bids received without duly filled in questionnaire shall not be considered for evaluation.
- 4. The rate quoted per unit in **Annexure-II** shall be on door delivery basis inclusive of excise duty, sales tax, packaging charge, freight charge, transit Insurance, installation and commissioning charge and any other incidental charge. The component of sales tax should also be shown separately.
- 5. Bids will be evaluated with reference to landed price to determine the lowest price.
- 6. The supply should be completed within 7 (seven) days from the date of purchase order. In case there is delay in delivery beyond the stipulated period there shall be reduction in

- price @ 0.5% of the value of delayed goods per week of delay or part thereof subject to a maximum of 10% of the total order value.
- 7. 100 % payments towards the supply of items will be made on submission of invoices with challans along with installation reports (certified by the Head of the Health Institution/ In-Charge of the SNCU) and warranty certificates in triplicate.
- 8. The supplier shall execute an agreement on non-judicial stamp paper of value of Rs.100/- (stamp duty to be paid by the supplier) as per the specified format within 7 days from the date of issue of the PO.
- Company/Firm/Manufacturer which has been blacklisted either by the Tender Inviting
 Authority or by any State Government or Central Government Organization shall not be
 allowed to participate in the tender during the period of blacklisting.
