SHORT NOTICE INVITING TENDER FOR SUPPLY & REFILLING OF D TYPE OXYGEN CYLINDER

Sealed quotations in two-bid System affixing court fee stamp of Rs 8.25 only, are invited from the manufacturer or their authorized dealers/distributors for supply & refilling of D Type Oxygen Cylinder under NVBDCP, Assam with following terms and conditions and as per format at Annexure I, II & III. The quotations should reach the office of the Mission Director, National Health Mission Assam, Saikia Commercial Complex, Christian Basti, Ghy-781005 by 2.00 P.M. on 13.07.2015. The sealed quotations shall be opened on the same day at 3.00 P. M. in the office of the Mission Director, NHM Assam.

- <u>Name of work</u> Supply & Refilling of D Type Oxygen Cylinder.
- Terms & Conditions:-
- Earnest Money Deposit (EMD) of Rs 15,000/- only in the form of Demand Draft/Banker's Cheque with validity of at least 3 months favoring "State Health Society, Assam". Earnest Money Deposit in any other form will not be accepted. Earnest Money Deposit will also not earn any interest.
- 2. The specification of the required items is given at Annexure I
- 3. Delivery of the ordered items shall be affected at District Hospitals of Golaghat, Sivsagar & Lakhimpur or as specified in the purchase order.
- 4. The quantity indicated in the bid document is tentative and subject to change depending on actual requirement.
- 5. The Bidder (whether a manufacturer or an authorized dealer/distributor of the manufacturer) shall have to submit Sales Tax Clearance certificate, as on 31st March of last financial year along with copy of Trade License and Drug License.
- 6. The Bidder who is not a manufacturer of Oxygen Cylinder shall submit valid authorization/ dealer certificate from the concerned manufacturer of Oxygen Cylinder.
- 7. The Bidder should also submit valid IS/BIS Certificates for both Cylinder and the Valve.
- 8. The technical & commercial requirements, wherever applicable, are specified in the attached questionnaire titled "Agreed Terms & Conditions" (Annexure-II) which should be filled in, signed & stamped on each page and shall be enclosed with your bid. Bids received without duly filled in questionnaire shall not be considered for evaluation.
- 9. The rate quoted per unit in **Annexure-III** shall be on door delivery basis inclusive of excise duty, sales tax, packaging charge, freight charge, transit Insurance, installation and commissioning charge and any other incidental charge. The component of tax should also be shown separately.
- 10. Bids will be evaluated with reference to landed price to determine the lowest price.

- 11. The supply should be completed within 7 (seven) days from the date of purchase order or as specified in the Purchase Order. In case there is delay in delivery beyond the stipulated period there shall be reduction in price @ 0.5% of the value of delayed goods per week of delay or part thereof subject to a maximum of 10% of the total order value.
- 12. 100 % payments towards the supply of items will be made on submission of invoices with challans along with test certificates (certified by the Head of the Health Institution/ In-Charge of the PICU) and warranty certificates in triplicate.
- 13. The supplier shall execute an agreement on non-judicial stamp paper of value of Rs.100/-(stamp duty to be paid by the supplier) as per the specified format within 7 days from the date of issue of the PO.
- 14. Company/Firm/Manufacturer which has been blacklisted either by the Tender Inviting Authority or by any State Government or Central Government Organization shall not be allowed to participate in the tender during the period of blacklisting.

ANNEXURE- I

Technical specification for Light weight Medical Oxygen Cylinder

Oxygen Capacity around – 7 Cubic Metre (D Type)

FOR MEDICAL OXYGEN CYLINDER (MADE OF SEAMLESS STEEL)

- 1. The Medical Oxygen cylinder should be made of Seamless Steel with heat sensitive coating.
- 2. Cylinder should be of IS/ BIS standard having the weight of around 50-55 Kg.
- 3. The capacity of the cylinder should be around **7 Cubic Metre** Medical Oxygen gas and 46.7 Itrs Water Capacity.
- 4. Cylinder should be fitted with valve safeguard and the same should be suitable to hand carry the cylinder.
- 5. Since portability of the cylinder is vital, the filling pressure of the cylinder should be minimum 150 Bar having test pressure of 250 Bar. Test certificates of the cylinders from the cylinder manufacturer should also be provided.
- 6. The colour code of the cylinders should be as per IS/BIS standards with all updating till date.
- 7. The valve fitted on top of the medical cylinder should be as per IS Standards so as to make sure that the cylinder is easily refilled anywhere in Assam and there is no need for any custom made refilling hose / station / connector. Also the cylinder so supplied should be easily connected to Gas Manifold System of the Hospital.
- 8. All fitting of medical oxygen cylinder should be leak proof and there should be no chances of leakages.
- 9. Medical Oxygen cylinders and all other fittings should be hygienic and there should be no chances of contamination.
- 10. All cylinders shall be supplied filled with Medical Oxygen gas and a Certificate as comply with IP standard shall be provided by the supplier for filled gas.
