The Office of the Mission Director, National Health Mission, Christian Basti, Guwahati-5 invites bid for the works under NHM **ON TWO BIDS SYSTEM**. as detailed below

1. Eligibility Criteria:

- (a) Registered APWD (Bldg) Class I-(A/B/C)/ CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking.
- (b) Contractor must have satisfactory completed
 - (i) Two similar works, each of value not less than 50% of the estimated cost put on tender or
 - (ii) One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited.
- (c) Contractor must have achieved Annual Turnover of at least Rs.130.00 lakhs in any **TWO YEARS** during last 5 years.
- (d) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hostel Building projects on earlier occasion.
- (e) The contractor who was earlier allotted any NHM works by PWD(B), Assam or by NHM and could not complete the work in all respect **in time** will not be **ELIGIBLE** to participate in the bidding process.
- (f) The contractor and to whom extension of time was granted from NHM imposing penalty will also be not **ELIGIBLE** to participate in the bidding process.
- (g) The intended bidders are asked to verify the site for the work prior to quoting their rates.
- 2. Cost of tender document should be drawn in favour of **State Health Society**, **Assam**, payable at **Guwahati** in the form of Pay Order/Demand Draft.
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the **State Health Society, Assam,** payable at **Guwahati**.
- 4. Date for issuing of Bid Document: <u>05/08/2015</u>
- 5. Last date and time of submission of Bid: 12/08/2015 at 14:00 hrs at the office of the Mission Director, NHM, Assam.
