DETAILED NOTICE INVITING "EXPRESSIONS OF INTERESTS" (EOI) FOR ASHA RADIO PROGRAMME UNDER NATIONAL HEALTH MISSION, ASSAM

National Health Mission, Assam invites "Expression of Interest" from interested producers/ production Houses for production of 30 Minutes ASHA Radio Program meant for ASHA Activities working in rural areas. The "Expression of Interest" will be in two bids: 1) Technical and 2) Financial. The program will be in Assamese and Bengali language that will be aired in All India Radio.

OBJECTIVE: -The programme is meant specifically for awareness generation of ASHAs and community in general.

The program will cover issues related to health and hygiene, different health related programmes or schemes implemented by Govt. and matters relating to ASHA Activities.

1) INVITATION FOR "EXPRESSION OF INTEREST"

"Expression of Interest" from reputed producers/ Production Houses to produce the programme and make arrangement to submit the audio CD of the program to the prescribed stations of All India Radio/Private Channels.

Format of the programme- AUDIO (Narration, dram, music, interview of ASHA's of all districts of Assam, one ASHA's interview per episode.)

Programme Duration: 30 minute each episode.

"Expressions of Interest" along with prescribed documents should be sent by post/courier service or in person so as to reach the place of submission (indicated below) on or before 2.00 PM of 22nd August, 2015.

3) **EVALUATION /SELECTION PROCEDURE:**

Valuation/selection shall be carried out in the following stages:-

- i) Agencies with sound financial background and reliable track record will be short-listed based on the responses against the notice inviting "expressions of interest".
- ii) The short listed agencies will be required to give presentation on a) experience of producing radio programme, b) details of resources at their command such as studio facilities c) availability of commercial artists for voiceover, background music, sound effects etc. The agency will be required to present one radio programme of 30

minutes duration produced by it which should be as per prescribed format mentioned under paragraph-2.

iii) The technical bid will be examined by the technical committee and only the shortlisted agencies.
