## EXTENSION NOTICE

The Bid process for the work "Construction of PHC in Riverine/Char areas at Dhalpur Bheti Bazar in Darrang District under NHM" (Balance Work) issued vide this office letter No.NHM/C-CW/ Riverine PHC/Dhalpur Bheti Bazar/Darrang/958/11/49659 Dated Guwahati the 24<sup>th</sup> July'15 is extended as follows:-

- I. Issue date of Bid document extended up to 27/08/2015
- II. Submission of Bid: <u>27/08/2015</u> at <u>14:00 hrs.</u>
- III. Opening of Bid: <u>27/08/2015</u> at <u>15:30 hrs.</u>
- IV. <u>Eligibility Criteria</u>:
  - (a) Registered APWD (Bldg) Class I-(A)/I-(B) & I-(C) /CPWD/Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking
  - (b) Contractor must have satisfactory completed
    - (i) Four similar works, each of value not less than 25% of the estimated cost put on tender or
    - (ii) Three similar works, each of value not less than 40% of the estimated cost put on tender or
    - (iii) Two similar works, each of value not less than 50% of the estimated cost put on tender or

(iv) One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited.

- (c) Contractor must have achieved Annual Turnover of at least Rs. 91.40 Lakh in any <u>TWO YEARS</u> during last 5 years.
- (d) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital related Building works under NHM on earlier occasion.
- (e) The contractor who was earlier allotted any NHM works and could not complete the work in all respect <u>in</u> <u>time</u> will not be ELIGIBLE to participate in the bidding process.
- (f) The contractor and to whom extension of time was granted from NHM imposing penalty will also be not <u>ELIGIBLE</u> to participate in the bidding process.
- (g) The intended bidders are asked to verify the site for the work prior to quoting their rates.

(h) The bids submitted earlier in this office on 06/08/2015 and 19/08/2015 will be considered in the above bid process.

(i) If the bidders desire to modify their financial bid, they can submit the modification in separate sealed envelope on the extended date & time of submission of bid. The envelope shall have clear marking "MODIFICATION TO FINANCIAL BID" as per relevant clauses of the Bidding document.
