- 1.The bidder shall be an accredited Channel Partner of MNRE engaged as manufacturer/supplier of Solar Photo Voltaic Systems in India under Jawaharlal Nehru National Solar Mission (JNNSM).
- 2.The bidder must have designed, supplied, tested, erected and commissioned solar power plant with minimum capacity of 50 KW (cumulative) in the range of 10 KW and above and which is/are in successful operation on the date of bid opening.
- 3.The bidder should have Average Annual Turnover of Rs 2.00 Crores or more during the last three financial year's i.e. 2012-13, 2013-14 and 2014-15.
