INVITATION FOR BIDS (IFB)

The Office of the Mission Director, National Health Mission, Christian Basti, Guwahati-5 invites bid for the works under NHM as detailed below **ON TWO BIDS SYSTEM**.

1. Eligibility Criteria:

- (a) Registered APWD (Bldg) Class I-A,B, C/Class-II/CPWD Contractors/Reputed Construction Company/Agency registered under Govt./Public sector undertaking.
 - (b) Contractors having at least one similar nature of completed work value not less than 80% of the proposed project cost during last 2(Two) years.
 - (c) Contractor must have Annual Turnover at least Rs 50.00Lakh in any One year during last 3(Three) years.
 - (d) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Building works under NHM on earlier occasion.
 - (e) The contractor who was earlier allotted any NHM works and could not complete the work in all respect in time/within the period up to which extension of time was granted without penalty will not be **ELIGIBLE** to participate in the bidding process.
 - (f) The contractor and to whom extension of time was granted from NHM imposing penalty will also be not **ELIGIBLE** to participate in the bidding process.
 - (g) The intended bidders are asked to verify the site for the work prior to quoting their rates.
 - (h) The intending bidders or their authorized representative may remain present at the time of opening of Bid.
2. Cost of tender document should be drawn in favour of **State Health Society, Assam**, payable at Guwahati in the form of Pay Order/Demand Draft.
 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of **TDR/FDR/CDR** and drawn in favour of the State Health Society, Assam, payable at Guwahati.
 4. Date of receipt of **application** alongwith cost of tender document and copies of documents as per eligibility criteria mentioned at Sl.1 (a), (b) & (c) to issue Bid Document: to **during working hours.**
 5. Date for issuing of Bid Document: -26-10-2015 to 27-10-15 up to 17- 00 hrs.
 6. Last date and time of submission of Bid: 30-10-2015 at **14-00 hrs**
 - a. The bids will be opened at 15.30 hrs of the same days as mentioned above.
 - b. In case, if any Bandh /Holiday fall in any sequence, the sequence will be held in the next working day.
