### INVITATION FOR BIDS (IFB)

The Office of the Mission Director, National Health Mission, Assam, Guwahati-5 invites bid for the works under NHM as detailed below **ON TURN KEY BASIS** and **ON TWO BIDS SYSTEM**.

#### Eligibility Criteria:

1. Registered APWD (Bldg) Class I-(A) (B) & (C) / CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking.
2. Up to date Registration Certificate, VAT, PAN, work completion certificate with supporting Work order, Labour Licence etc. must be produced at the time of purchasing bid document.
3. Contractor must have satisfactorily completed one similar work of value not less than 80% of the estimated cost or Two similar works, each of value not less than 50% of the estimated cost put on the tender, the amount rounded off to the convenient full figure, in the last five years ending on the last day of the month previous to the one in which the tender is invited.
4. Contractor must have achieved Annual Turnover of at least Rs.1.11 Crores in any TWO YEARS during last 5 years.
5. In case the evaluated Bid Amounts are equal, preference for allotment of the work will be given to the bidder having the highest Bid capacity
6. The contractor who was earlier allotted any NRHM works by PWD (B), Assam or by NRHM and could not complete the work in all respect in time/within the period up to which extension of time granted without penalty will not be ELIGIBLE to participate in the bidding process
7. The contractor to whom extension of time was granted from NRHM **imposing penalty** will also be not ELIGIBLE to participate in the bidding process
8. The intended bidders are asked to verify the site for the work prior to quoting their rates.
9. Cost of tender document should be drawn in favor of State Health Society, Assam, payable at Guwahati in the form of Pay Order/Demand Draft from nationalized bank. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of TDR/FDR/CDR and drawn in favour of the State Health Society, Assam, payable at Guwahati.
1. **Date of receipt of application** along with cost of tender documents and copies of documents as per eligibility criteria mentioned at Sl.(1),Sl.(3),Sl.(4) to issue bid document:27/10/2015 to 28/10/2015
2. **Date for issuing of Bid Document:-** 03/11/2015 during working hours
3. **Date and time of submission of Bid:** 07/11/2015 upto 14:00 hrs at the office of the Mission Director, NHM, Assam
4. The bids will be opened at 15.30 hrs of the same day as mentioned above.
