**Eligibility Criteria:**

1. Registered APWD (Bldg) Class I-A/B/C/ CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking.
2. Contractors who have not executed pre-fabricated steel structure works values not less than 20% of the estimate cost during last 5(five) years will not be eligible to participate in the bid process. [Certificate of completion of steel structure work must be produced at the time of purchasing bid document].
3. Contractor must have satisfactory completed civil works of value not less than 40% of the estimated cost in the last 5 years.
4. Contractor must have achieved annual turnover of at least 80% of value of work put on tender in any ONE YEAR during last 5 years.
5. In case the evaluated Bid Amounts are equal, preference for allotment of the work will be given to the bidder having the highest Bid capacity
6. The contractor who was earlier allotted any NRHM works by PWD (B), Assam or by NRHM and could not complete the work in all respect in time with the period up to which extension of time granted without penalty will not be ELIGIBLE to participate in the bidding process
7. The contractor to whom extension of time was granted from NRHM imposing penalty will also be not ELIGIBLE to participate in the bidding process
8. The intended bidders are asked to verify the site for the work prior to quoting their rates.
9. Cost of tender document should be drawn in favor of State Health Society, Assam, payable at Guwahati in the form of Pay Order/Demand Draft from nationalized bank. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of FDR/CDR and drawn in favour of the State Health Society, Assam, payable at Guwahati
10. Date for issuing of Bid Document:-04/01/2016 to 06/01/2016 during working hours
11. Last date and time of submission of Bid: 16/01/2016 at 14:00 hrs at the office of the Mission Director, NHM, Assam
12. The bids will be opened at 15.30 hrs of the same day as mentioned above.
