CORRIGENDUM – 1 & EXTENSION NOTICE

**NOTICE INVITING TENDER
FOR DESIGN, DEVELOPMENT AND IMPLEMENTATION OF MOBILE
APPLICATION FOR NATIONAL HEALTH MISSION ASSAM**

This has reference to Tender No: NHM/MobileApp/2685/2015-16/20571 dated 24/12/2015 for Design, Development and Implementation of Mobile Application for National Health Mission, Assam.

A) Clarifications as per queries raised in the pre-bid meeting:

Following clarifications highlighted as per queries raised in the pre-bid meeting held on 8th January 2016:

1. There shall be no change in the pre-qualification criteria as mentioned in the Tender document.
2. As mentioned in the clause no 10 of the Tender document, “The Delivery, installation & implementation shall be completed within 2 Months on placement of the purchase or work order”. There shall be no change in the delivery period.
3. There shall be no change in the Technical Specification as mentioned in the Tender document.
4. In the meeting, it was requested to clarify the process of flow of data from NHM server to the Mobile Application.

It was clarified that, separate database need not required to be created for the Mobile Application. It will share database of NHM server. However, separate tables may be required to create for the mobile application as per requirement. It was also clarified that, database structure, user id and password shall be shared with the development team to access database from the NHM server. The MIS team of NHM Assam shall cooperate with the development team regarding database access. It was also informed that, presently NHM is using MySQL database in the server. It was also clarified that, the system will be hosted in the NHM Server.

5. As per clause no 1(m), “Maintenance, Implementation and support must be provided with as part of the Tender”. It was requested to clarify the time period of maintenance, implementation and support.

It was clarified that, as per clause 2(t) of the Tender Document, “Successful bidder will have to provide comprehensive warranty for 1 year after final implementation of the Application into live server.” Further, as per clause no 2(u) “Maintenance of the application should be provided for 5 (five) years after the expiry of warranty period.”

6. As per clause no 1(n), "No extra cost shall be paid by NHM for supply, installation and implementation, updation/ upgradation of any software/device wherever it is necessary for its optimum functioning." It was requested to clarify that for how long No extra cost shall be paid by NHM for supply, installation and implementation, updation/ upgradation of any software/device wherever it is necessary for its optimum functioning.

It was clarified that, as per clause 2(t) of the Tender Document, "Successful bidder will have to provide comprehensive warranty for 1 year after final implementation of the Application into live server." Further, as per clause no 2(u) "Maintenance of the application should be provided for 5 (five) years after the expiry of warranty period."

It was clarified that, extra payment shall not be made if there is change in the scope of the Mobile Application. Successful bidder will have to do the extra work without charging any extra cost.

A few terms & conditions of the Tender have been amended following pre-bid meeting held on 8th January 2016. Following terms & conditions of the Tender have been amended further which should be taken note of prior to submission of bids:
