INVITATION FOR BIDS (IFB)

The Office of the Mission Director, National Health Mission, Assam invites bid for the works under NHM as detailed below ON TWO BIDS SYSTEM.

1. Eligibility Criteria:

- (a) Registered APWD (Bldg) Class I-(A)/I-(B)/I(C)/CPWD/Agency registered under Govt. /Public Sector undertaking
- (b) Contractor must have satisfactory completed
 - (i) Two similar works, each of value not less than 50% of the estimated cost put on tender or
 - (ii) One similar works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited.
- (c) Contractor must have achieved Annual Turnover of at least Rs. 85.12 Lakh in any <u>TWO YEARS</u> during last 5 years.
- (d) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital related Building works under NHM on earlier occasion.
- (e) The contractor who was earlier allotted any NHM works and could not complete the work in all respect <u>in time</u> will not be ELIGIBLE to participate in the bidding process.
- (f) The contractor and to whom extension of time was granted from NHM imposing penalty will also be not <u>ELIGIBLE</u> to participate in the bidding process.
- (g) The intended bidders are asked to verify the site for the work prior to quoting their rates.
- 2. Cost of tender document should be drawn in favour of **State Health Society**, **Assam**, payable at **Guwahati** in the form of Pay Order/Demand Draft.
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of FDR/CDR and drawn in favour of the **State Health Society**, **Assam**, payable at **Guwahati**.
- 4 Date of receipt of **application** along with cost of tender document and copies of documents as per eligibility criteria mentioned at SI.1 (a), (b) & (c) to issue Bid Document: <u>15/02/2016</u> to <u>16/02/2016</u> during working hours.
- 5 Date for issuing of Bid Document: <u>19/02/2016</u> during working hours.
- 6 Last date and time of submission of Bid: <u>22/02/2016</u> at <u>14:00 hrs.</u> at the office of the Mission Director, NHM, Assam.
