## 1. Eligibility Criteria:

(a)Registered APWD (Bldg) Class I-A,B,C /Class-II/CPWD Contractors/Reputed Construction Company/ Agency registered under Govt./Public sector undertaking.

- (b)Contractors having at least one similar nature of completed work value not less than 80% of the proposed project cost during last 2(Two) years.
- (c) Contractor must have Annual Turnover at least Rs. 56.00Lakh in any one year during last 3 (Three) years.
- (d) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Building works under NHM on earlier occasion.
- (e) The contractor who was earlier allotted any NHM works and could not complete the work in all respect in time/within the period up to which extension of time was granted without penalty will not be <u>ELIGIBLE</u> to participate in the bidding process.
- (f) The contractor and to whom extension of time was granted from NHM imposing penalty will also be not <u>ELIGIBLE</u> to participate in the bidding process.
- (g) The intended bidders are asked to verify the site for the work prior to quoting their rates.
- (h) The intending bidders or their authorized representatives are to be present at the time of opening of Bids. Otherwise the bids will be opened in their absence and no claim will be entertained in future.
- 2. Cost of tender document should be drawn in favour of **State Health Society**, **Assam**, payable at Guwahati in the form of **Pay Order/Demand Draft**.
- 3. Bid security with a validity of 225 (i.e.180+45) days should be in the form of **TDR/FDR/CDR** and drawn in favour of the State Health Society, Assam, payable at Guwahati.
