CORRIGENDUM 1

NOTICE INVITING TENDER FOR RATE CONTRACT OF DEIC EQUIPMENTS/DIAGNOSTIC TOOLS

This has reference to the tender No:NHM/PROC/RBSK/DEIC-EQP/ 2629 /2015-16/21889 Date: 04/02/2016 for entering into rate contract for supply & installation of Equipments/Diagnostic Tools at District Early Intervention Centers (DEIC). The following clarifications may be taken note of prior to submission of Bids:

1. **Clause 3: ELIGIBILITY CRITERIA is amended to be read as follows:**

Point No. C.

Manufacturer participating as bidder or manufacturer from whom the tendered items would be sourced by the dealer should have an average Annual Turnover of **Rs.200.00 Lakhs** in the last 3 financial years i.e. 2012-13, 2013-14 & 2014-15 instead of Rs.530.00 Lakhs.

Point No. E.

Bidder shall have experience in supply & installation of Hospital Equipments & Instruments in the last 3 (three) financial years and value of a single order for similar items awarded by a Govt. organization during this period should be at least **Rs.6.60 Lakhs** instead of Rs.13.Lakhs.

2. **Clause 5: TECHNO-COMMERCIAL BID - COVER "A"**

Point No. k. Execution of similar contracts of Bidder:

Details of supplies (Medical Equipments/Instruments/Diagnostic Tools) made during the past 3 financial years with summary of Purchase Orders and Performance Certificates issued by clients in the specified format (Refer **Annexure V**). Items supplied to Govt. institutions and to programs sponsored by WHO, UNICEF etc., if any, during the past 3 years should be highlighted. Copies of at least three orders including one single order awarded by a Govt. Organization of value at least **Rs.6.60 Lakhs** executed during the last 3 financial years should be submitted.

3. **Regarding submission of ISO Certificate:**

Authorised Bidders/Manufacturers should submit ISO certificate of the Company/Firm whose product has been quoted.
