1. Eligibility Criteria:

- (a) Registered APWD (Bldg) Class I-(A)/I-(B) & I-(C)/II Class/CPWD/Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking.
- (b) Contractors who have not executed Pre- fabricated steel structure works value not less than 20% of the estimated cost during last 5(Five) years will not be eligible to participate in the bid

process.(Certificate of completion of steel structure work must be produced at the time of purchasing bid document).

- (c) Contractor must have satisfactory completed Civil Works of value not less than 80% of the estimated cost, all amounts rounded off to a convenient full figure, in the last 5 years ending on the last day of the month previous to the one in which the tenders are invited.
- (d) Contractor must have achieved Annual Turnover of at least 80% each of value of work put on tender in any <u>TWO YEARS</u> during last 5 years.
- (e) The Contractor having PAN Card/VAT Registration/Labour License registration under EPF & MP Act,1952 etc. are eligible to participate in the bid process
- (f) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Quarter related Building works under NHM on earlier occasion.
- (g) The contractor who was earlier allotted any NHM works and could not complete the work in all respect in time will not be ELIGIBLE to participate in the bidding process.
- (h) The contractor and to whom extension of time was granted from NHM imposing penalty will also be not <u>ELIGIBLE</u> to participate in the bidding process.
- (i) The intended bidders are asked to verify the site for the work prior to quoting their rates.
- 2. Cost of tender document should be drawn in favour of State Health Society, Assam, payable at Guwahati in the form of Pay Order/Demand Draft.
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of FDR/CDR and drawn in favour of the State Health Society, Assam, payable at Guwahati.
- 4. Date of receipt of **application** along with cost of tender document and copies of documents as per eligibility criteria mentioned at Sl.1 (a), (b), (c), (d) & (e) to issue Bid Document: **04/07/2016** to **05/07/2016** during working hours.
- 5. Date for issuing of Bid Document: <u>08/07/2016</u> during working hours.
- Last date and time of submission of Bid: <u>12/07/2016</u> at <u>14:00 hrs.</u> at the office of the Mission Director, NHM, Assam.
- 7. In case, if any Bandh/Holiday falls in any sequence, the sequence will be held in the next working day.
