CORRIGENDUM No -1

<u>Tender for selection of firm for "Provision of Computed Tomography (CT) Scan at District Hospital"</u>

This has reference tender NO: NHM/Free Diagnostic Services Pt II/2015-16/2700/2739, dated: 8/6/2016 for selection of firm for "Provision of Computed Tomography (CT) Scan at District Hospital". The following amendments may be taken note of prior to submission of bid.

- 1. Regarding Clause -3 under "Scope of the work" (Section 4) of the bid document it is clarified that time schedule etc. mentioned is applicable only for functional machines.
- 2. Clause -6 under "Terms & Conditions" (Section-6) of the bid document is amended to read as follows:

"The payment will be made on monthly basis not extending beyond 12 noon of the last bank working day of the month through ECS for all invoices raised. The purchaser shall give standing instructions to the bank for implementation of this requirement. The bidder will raise its invoice on completion of services during this period duly accompanied by evidence of services provided. The payment will be subject to TDS as per Income Tax Rules and other statutory deductions as per applicable laws.

3. Clause 8 under "Terms & Conditions" (Section – 6) of the bid document is amended to read as follows:

"The purchaser may terminate the contract, if the successful bidder withdraws its tender after its acceptance or fails to submit the required performance securities for the initial contract and or fails to fulfill any other contractual obligations. In that event, the purchaser will have the right to purchase the same goods/equipment from next eligible bidder and the extra expenditure on this account shall be recoverable from the defaulter. The earnest money and the performance security deposited by the defaulter shall also be recovered to pay the balance amount of extra expenditure incurred by the purchaser. Service provider shall commence the proposed services within the 120 days of signing of the agreement otherwise the contract could be terminated".

4. Clause 11(point no gg) under "Terms & Conditions" (Section – 6) of the bid document is amended to read as follows:

"The successful bidder will provide hard copy of the report along with image to the patient and soft copy of image (in the form of email) & hard copy of report (in the form of paper) to the respective district authority on daily basis. Soft copy of images in the form of CD may be submitted to the district on monthly basis".

5. Regarding Clause -6 under "Eligibility Criteria" (Section - 5) of the bid document it is clarified that:

"In case of Consortium the lead partner should independently meet both the technical and financial eligibility criteria. In case of consortium, financial turnover of only those bidders would be collectively considered who individually meet the technical eligibility criteria"

- 6. A single bidder will be selected for providing services at all district hospitals in the state.
- 7. OPD/IPD data available on NHM, Assam website may be utilized by the Prospective bidders for load calculation.
- 8. All the modalities (Space, manpower, Infrastructure, Logistic, Electricity etc. required for providing CT Scan services will be responsibility of the service provider.
- 9. The service provider can adopt any one out of available two options given below for providing CT scan services:
 - I. The service provider will arrange space at its own cost in proximity to the hospital and then make complete arrangements (including procurement of 16 slice CT scan) and terms & conditions laid down in the bid document.
 - II. The service provider partners with an already existing CT scan facility near the hospital and makes it operational as per the specifications of the machine (16 slice CT scan) and terms & Conditions laid down in the bid document.
- 10. Tele Radiology may be used for reporting. All the HR required for providing the services will be the responsibility of the service provider.
- 11. Contract value for submission of performance security shall be calculated as 10 CT Scan x 300 days x quoted price.
- 12. Service of Anesthetic Doctor shall be the responsibility of the service provider, which can be arranged on call basis.
- 13. Reimbursement will be made only for those patients, referred by the govt. institutions. Service provider may charge private patients as per their own rate.
- 14. No new installation can use refurbished machine.
- 15. User rates shall be raised every year by 5%.

Revised bidding schedule is as follows:

• Closing date & Time of Receipt of Bid : 8/8/2016 up to 2.00 Pm

• Date & Time of opening of Technical Bid: 8/8/2016 at 3.00 Pm

All other terms & conditions of the tender shall remain unchanged.
