## <u>Tender for selection of firm for "Provision of Computed Tomography (CT) Scan at</u> District Hospital"

This has reference tender NO: NHM/Free Diagnostic Services Pt II/2015-16/2700/2739, dated: 8/6/2016 and Corrigendum No: NHM/Free Diagnostic Services PtII/2015-16/2700/6119, dated: 18/07/2016 & NHM/Free Diagnostic Services PtII/ 2015-16/2700/7960, dated: 3/08/2016 for selection of firm for "Provision of Computed Tomography (CT) Scan at District Hospital". The following amendments may be taken note of prior to submission of bid.

- 1. Single Service provider will be selected for all districts.
- 2. Space in the newly constructed Diagnostic Centre in districts will be provided to successful bidder for installation and operation of CT Machine.
- 3. Details of Diagnostic Centre location provided at annexure A ( Rev-1)
- **4.** A minimum monthly rent @ Rs. 5.00 per sq.ft. of allotted space will be charged from the successful bidder with 5% escalation every year.
- 5. Payment of electricity bill will be responsibility of the successful bidder. NHM will provide separate electric meter.
- 6. NHM will provide 100KVA generator for each Diagnostic Center. Operation, maintenance etc. will be responsibility of the service provider.
- 7. In case of requirement of additional power (in addition to 100KVA Diesel Generator) service provider will be responsible for procurement of small DG Set at their own cost.
- 8. Prospective bidders will quote single rate for all types of CT Scan including contrast.
- 9. An amount of Rs. 1.00 crore will be put separately for assurance of payment without delay.

- 10. Performance Bank Guarantee of the successful bidder will be released after installation & commissioning of the CT scan at all centers.
- 11. Obtaining AERB certification will be the responsibility of the service provider.
- 12. Service provider will provide service free of cost to all beneficiaries referred by Govt. institution. The cost will be reimbursed by NHM on monthly basis.
- 13. Service provider will be entitled to charge private beneficiaries as per their own rate.
- 14. Renovation, Interior decoration & logistics will be responsibility of service provider.
- 15. Maintenance of electrical accessories and infrastructure will be responsibility of the service provider during the contract period.
- 16. Security & Housekeeping will be responsibility of the service provider.
- 17. Bio Medical waste management will be responsibility of the service provider.
- 18. APPENDIX –A (CT Scan Gap Analysis) of this bid shall stand replaced by **APPENDIX A** (Rev-1) included in this document.
- 19. Regarding Clause -3 under "Eligibility Criteria" (Section 5) of the bid document it is amended to read as follows:

"The bidder shall have at least Two CT Scan Service Centre (with fully trained service personnel) and providing reports for a minimum of 2000 radiology images per annum in one or more states of India"

20. Regarding Clause -1 under "Eligibility Criteria" (Section - 5) of the bid document is amended to read as follows:

"The Bidder shall be a sole provider (Company/Society/Trust) or a group of companies (maximum3) coming together as Consortium to implement the Project. The consortium with a Lead Member should have at least 75% stake of the consortium and must also have all legal liabilities. The bidder cannot be an individual or group of individuals. The Service provider should be registered as a legal entity such as company registered under Companies Act, Societies Registration Act, Trust Act or an equivalent law applicable in the region/state/country. A bidder cannot bid as a sole provider as well as a partner in a consortium. No bidder can place more than one bid in any form. In support of this, the bidder's letter shall be submitted as per proforma in **Appendix 'B'**"
