- (a)Registered APWD (Bldg) Class I-A,B,C /Class-II/CPWD Contractors/Reputed Construction Company /Agency registered under Govt / Public sector undertaking.
- (b)Contractors having at least one similar nature of completed work value not less than 80% of the proposed project cost during last 5(Five) year.
- (c) The Contractor having PAN Card/VAT/Registration/LabourLicence/ registration under EPF and MP ACT,1952 etc are **ELIGIBLE** to participate in the bid process.
- (d) The contractor who was earlier allotted any NHM works by APWD (B), ASHB or by NHM and could not complete the work in all respect in time/within the period up to which extension of time was granted without penalty will not be **ELIGIBLE** to participate in the bidding process.
