Please read:

“**N.B.** Manufacturers who do not produce 16 size aortic heart valves at this stage can also participate in the tender process provided they give in writing that they will also manufacture and supply 16 size aortic heart valves if they are selected in the bidding as per the specification of this tender. Heart valve sizes are actually determined once operation procedure is in process. Most of the aortic position in our group of patients need small sized valves. Hence, aortic heart valve size No. 16 is required.” *appearing as a footnote in Schedule-3 Technical Specifications in the Bid Document of Heart Valves vide this Directorate tender No: HSPB/11/Heart Valve/2012-13/830 dated 30/08/12.*

"N.B. Manufactures who do not produce 16 size heart valves can also participate in the tender process for the other sizes. However, there is one condition for successful bidder that there must be scope for replacement of any size valve as may be required during the process of operation."
