**Corrigendum No 1.
(e-TENDER FOR SUPPLY OF DRUGS)**

This is with reference to tender no. NHM/PROC/CH/SNCU/DRUGS/2594/2015-16/7777 dated 3/10/2016 for supply of drugs. The following amendments in the tender may be taken note of prior to submission of bids:

1. Sub Clause D under Clause 3 (Eligibility Criteria) is amended to read as follows:
Manufacturer participating as bidder or manufacturer from whom the drugs, ampoules or injectibles, etc shall be sourced by a distributor/dealer should have an Average Annual Turnover of not less than **Rs 50.00 (Fifty) Crores** during the last three financial years 2012-13, 2013-14 & 2014-15 or 2013-14, 2014-15 & 2015-16. Manufacturer participating as bidder or manufacturer from whom surgical items shall be sourced by a distributor/dealer should have an Average Annual Turnover of not less than **Rs 5.00 (Five) Crores** during the last three financial years 2012-13, 2013-14 & 2014-15 or 2013-14, 2014-15 & 2015-16.
2. Sub Clause E under Clause 3 (Eligibility Criteria) is amended to read as follows:
“Manufacturers of Drugs items covered under the Drugs & Cosmetics Act shall possess valid **WHO- GMP** certificate issued by the Licensing Authority but for Surgical items GMP certificate will be applicable. For Nappy Pads GMP Certificate is not required but ISO 9001:2008 or ISO 13485:2003 will be required.”
3. Annexure IX (List of Items quoted with name of Manufacturer) is substituted with Annexure IX (Rev-I) included in this document.
4. Annexure XIII (Price Bid) is substituted with Annexure XIII (Rev-I) included in this document.
5. Annexure XIV (Details of items with quantities) is substituted with Annexure XIV (Rev-I) included in this document.
